The registration fee is \$160 to lodge your EPA with Landgate.

The main benefit of registering your EPA is that, if necessary, your attorney(s) can deal with your real property quickly and efficiently. If you do not register your EPA and your attorneys need to deal with your real property, and if it is more than 3 months after the date of signing your EPA, your attorney(s) will have to lodge a statutory declaration in order to register the EPA with Landgate. This will involve further expense and delay.
